# Head 93 - Ministry of Home Affairs HQ

(2025/26 EST) B-310) Line Item 103000 Administration \$2,439M Revenue and Line Item 103010 Consumer Affairs-Admin: Significant Increase in Headquarters Budget

**Question 1:** The Ministry of Home Affairs Headquarters' budget has increased from \$1.796 million in the revised 2024/25 to \$2.439 million in the 2025/26 estimate, representing a 36% increase, plus additional funds of 1,145M under Line Item 103010 Consumer Affairs-Admin. Can the Junior Minister provide a detailed breakdown of the factors contributing to this substantial increase?

# (2025/26 EST) B-310) Estimate, \$1.420M Object Code Description, Line-Item Professional Services

**Question 2:** The Ministry of Home Affairs Headquarters, under the Object Code Description, Professional Services has increased from \$590,000 in the previous fiscal year to \$1.42 million for 2025/26 - an increase of \$830,000 or approximately 141%. Could the Junior Minister provide a detailed explanation of what specific

professional services or contracts account for this substantial increase, and how these expenditures align with the Ministry's strategic priorities for the year ahead?

# (2025/26 EST) B-310) Estimate, \$1.734M Object Code Description, Line-Item Salaries

Question 3: Under Head 93 for the Ministry of Home Affairs Headquarters Administration, the number of staff remains constant at 8, yet the salary expenditure has increased by \$874,000 which is approximately 101%. Could the Junior Minister clarify the reason for such a significant increase in compensation without any increase in personnel? Does this reflect union increases, reclassifications, promotions, or the inclusion of new executive-level posts within the Headquarters allocation?

## Head 89 - Energy

# (2025/26 EST) B-313 - Line Item 99000 Administration \$550,000

Question 1: The budget for the Energy Department has decreased from \$550,000 2024/25 to \$526,000 in this fiscal year. Given the importance of energy reform, sustainability goals, and the Integrated Resource Plan, can the Junior Minister explain how this reduced allocation supports Bermuda's national energy priorities? Are there concerns that this decrease may slow down progress on renewable energy adoption, regulatory improvements, or public education efforts?

# (2025/26 EST) Expenditure, Advertising & Promotion, B-314

**Question 2:** The budget allocation for Advertising and Promotion within the Energy Division is just \$1,000 for 2025/26. Given Bermuda's urgent need to educate the public on energy conservation, renewable technologies, and the Integrated Resource Plan (IRP), can the Junior Minister explain how the Department plans to conduct any meaningful public outreach or education with such a minimal budget? Is there another funding mechanism being used to supplement public awareness efforts?

**Question 3:** While the Department of Energy's operational budget is modest, can the Junior Minister advise whether any capital funds have been allocated elsewhere in the Estimates - perhaps under capital development or through quangos like BEDC or BLMC for the development of renewable energy infrastructure, such as solar, wind, or grid improvements? If so, how are these efforts being coordinated with the Energy Division to ensure alignment with the Integrated Resource Plan (IRP)?

#### (2025/26 EST) Expenditure, Salaries, B-314

**Questions 4:** The Energy Division is projected to generate \$15.385 million in revenue, yet its total expenditure is just \$526,000, of which \$514,000 is allocated to salaries. Can the Junior Minister clarify where this substantial revenue is being directed, and whether any of it is being reinvested into renewable energy initiatives, infrastructure development, or public energy programs? Is there a plan to expand the operational capacity of the Energy Division to ensure this revenue supports Bermuda's long-term energy transformation goals?
