Q1 *Will the Honourable Minister please inform this Honourable House of the names of the companies that have applied for a licence under Section 114B of the Companies Act during the year 2014?*

A1 **In 2014, the Ministry received a total of twenty-six (26) section 114B licence applications; of which, seventeen (17) were new/initial (or first-time) licence applications and nine (9) were renewal applications. Please refer to Annex 1.**

A2 **In 2014, the Ministry granted a total of twenty-three (23) section 114B licences. Please refer to Annex 1.**
