CHILD DAY CARE ALLOWANCE AMENDMENT REGULATIONS 2026

BR 73 / 2026

The Minister responsible for financial assistance, in exercise of the power conferred by section 17 of the Child Day Care Allowance Act 2008, makes the following Regulations:

Citation

1 These Regulations may be cited as the Child Day Care Allowance Amendment Regulations 2026.

Amends regulation 4

2 Regulation 4(2) of the Child Day Care Allowance Regulations 2008 is amended by deleting "regulation 5(2)," and substituting "regulations 5(2) and (2A),".

Amends regulation 5

3 Regulation 5 of the Child Day Care Allowance Regulations 2008 is amended as follows—

- (a) in paragraph (2) by deleting the words "for an eligible child" and substituting "to an applicant who has one eligible child";
- (b) by inserting after paragraph (2)—

"(2A) The maximum award that may be granted by the Director to an applicant who has multiple eligible children is—

- (a) for the first eligible child—

- (i) \$900 per month in respect of an applicant whose gross annual household income falls within category 1;
 - (ii) \$700 per month in respect of an applicant whose gross annual household income falls within category 2;
 - (iii) \$500 per month in respect of an applicant whose gross annual household income falls within category 3,
or the monthly cost of the child’s day care, whichever is less;
- (b) for the second eligible child—
- (i) \$1,275 per month in respect of an applicant whose gross annual household income falls within category 1;
 - (ii) \$1,225 per month in respect of an applicant whose gross annual household income falls within category 2;
 - (iii) \$1,175 per month in respect of an applicant whose gross annual household income falls within category 3,
or the monthly cost of the child’s day care, whichever is less;
- (c) for each additional eligible child after the second eligible child—
- (i) \$1,350 per month in respect of an applicant whose gross annual household income falls within category 1;
 - (ii) \$1,330 per month in respect of an applicant whose gross annual household income falls within category 2;
 - (iii) \$1,310 per month in respect of an applicant whose gross annual household income falls within category 3,
or the monthly cost of the child’s day care, whichever is less.”.

Amends regulation 6

4 Regulation 6(5) of the Child Day Care Allowance Regulations 2008 is amended by deleting “Regulation 5(2),” and substituting “Regulation 5(2), (2A),”.

Commencement

5 These Regulations shall come into operation on 1 September 2026.
